# TERMS AND CONDITIONS OF THE "END OF THE MONTH PODCAST" PRIZE DRAW

The company **IMAGINERSGEN, S.A.**, with registered office in Barcelona, Calle Estany, 1-11, planta 5 (08038) and Tax ID A-61363339 (hereinafter, "**IMAGIN**"), will hold a promotion aimed at individuals 18 and over whose tax residence is in Spain (i.e., the Iberian Peninsula, Balearic Islands, Canary Islands and Autonomous Cities of Ceuta and Melilla) and who also fulfil the criteria, requirements and terms and conditions set forth in these Legal Terms and Conditions (hereinafter, "**Terms and Conditions**"), offered as a free giveaway (hereinafter "**Draw**") to be held on the dates and under the circumstances specified herein.

### ONE. Requirements, entry period, and date of the Draw.

The draw is open to any individuals who meet the requirements set forth in **Condition THREE**.

The Draw will be held on the EasyPromos platform on the date indicated in the "DATE OF THE DRAW" section.

The **ENTRY PERIOD** will begin on 01 June 2025 and end on 25 June 2025 at 23:59 hours. Anyone who enters the Draw after the Entry Period has ended will not be considered a valid participant of the Draw.

### TWO. Prizes

The prize (hereinafter, the "**Prize**") will consist of a sum of money that will accumulate with each episode of the podcast. The podcast guests will voluntarily deposit an amount of money into a current account. This money will continue to build up in each episode so that it can be raffled amongst our social media followers at the end of the season.

A draw will be held, resulting in a single winner, in the manner specified in **Condition FOUR**. The participant awarded the Prize (hereinafter, the "**Winner**") must fully comply with all the requirements set forth in **Condition THREE**, as well as any other conditions outlined herein.

### THREE. - Who can participate?

3.1 Those who enter the prize draw will be customers, who, during the entry period meet all the following requirements:

3.2 The prize draw may not be entered by the following customers, even if they meet the requirements in section (3.1):

### SIX. Notification of the Winner and delivery of the prize

IMAGIN will notify the Winner via a private message on the social media platform Instagram, sent from IMAGIN's official Instagram profile (@imagin), starting on 26 June 2025. The message will inform the Winner of the Prize awarded, as well as of any modifications that may arise concerning the Prize as a result of this Draw.

The Winner will have a period of forty-eight (48) hours from the time of notification to contact IMAGIN and confirm their acceptance of the Prize. Once the Winner has accepted the Prize under the stipulated terms, IMAGIN will inform them of the method of Prize delivery, also via a private message on the Instagram social network.
